## Disclosure Questionnaire Category: Animal Testing

<b>Topic</b>	The company tests their supplemental products for efficacy at a third party testing facility.
<b>Summary of Issue</b>	Lintbells outsources and engages the third parties to conduct efficacy studies on selected products. These studies are undertaken to substantiate product claims and demonstrate product performance. For example, studies may evaluate the effectiveness of joint health supplements in supporting mobility, comfort and quality of life outcomes in animals. The purpose of this research is to generate robust scientific evidence supporting the efficacy of the products.
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	Based on a SKU-by-SKU review weighted by forecast 2026 gross sales value, we estimate that approximately 99% of products (by annual revenue) have undergone some form of animal testing (e.g. palatability and/or efficacy testing) at some point during their development process.
<b>Impact on Stakeholder(s)</b>	Animal testing and experimentation is widely used to develop and to test the safety of new agricultural products, pet products or other products. Many of these experiments could potentially cause pain to the animals involved or in some cases reduce their quality of life in other ways.
<b>Implemented Management Practices</b>	<p>Both Lintbells and Massey University anchor their animal testing practices in the 3Rs framework — Replacement, Reduction, and Refinement. Vetnique commits to using only non- or minimally-invasive methods, pursuing animal studies only where *in vitro* alternatives are insufficient, and involving the minimum number of animals necessary. Massey University enforces the same principles through its Animal Ethics Committee (AEC), which must approve all research before it commences and grades every study by ethical cost, with stricter scrutiny applied to higher-impact work.</p> <p>Oversight and governance are robust on both sides. Lintbells requires all third-party research partners — including outsourced labs like Massey — to meet its welfare standards through contractual obligations, and reserves the right to audit compliance. Massey's AEC, comprising at least 11 members including independent external representatives, conducts both</p>



	<p>scheduled and unscheduled monitoring visits, mandates adverse event reporting, and can suspend or revoke approvals at any time.</p> <p>Together, the two organisations form a layered system of accountability. Lintbells sets the ethical standards and contractual requirements at the company level, while Massey's AEC provides independent institutional governance on the ground. Both require formal ethical approval before any testing begins, prohibit studies that cause unnecessary harm or pain, and maintain transparent records — with Massey reporting animal use statistics annually to New Zealand's Ministry for Primary Industries.</p>
<b>Management Comments</b>	<p><i>Research is pursued to test the palatability and/or efficacy of products made from regulated and safe ingredients under strict ethical approval and animal welfare laws. These are non-medicinal products and no research causing harm or quality of life impacts would be undertaken.</i></p>
