Disclosure Questionnaire Category: Litigation and Arbitration

Issue Date	2023
Topic	Litigation and Arbitration related to consumer complaints and an employee redundancy plan challenge.
Summary of Issue	Evaneos acts as an intermediary between travellers and the local agencies on its platform. Because of this, there have been instances where the company is required to intervene in disputes related to the trips sold by these agencies regarding poor performance of travel contract, physical injury, cancellations due to extraordinary issues. Most of the cases have been settled in favour of the consumer. Four cases are pending resolution. There is one litigation case involving an employee challenging the company's redundancy plan during Covid. The case has been settled with the Labour Court granting 20% of the amount claimed.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	For the 17 litigation and arbitration cases which were settled, the settlement amount was €122,907 which represents <1% of the company's revenue for the year ending 2023. For the 4 pending cases, the cases are still ongoing and the amount is not determined at the present moment.
Impact on Stakeholder(s)	For the consumer cases, the impacted stakeholders were the travellers who purchased their holiday packages via Evaneos's platform. For the single labour case, the affected stakeholder is the employer and the related employee.
Resolution	For settled cases, it was resolved via financial settlement.
Implemented Management Practices	Reminder to travel agencies available on the platform of the rules applicable under the European Directive on Package Travel Sales (itinerary accuracy, quality service and high safety standards). Evaneos emphasised that for cases with similar issues, it originated from different travel agencies and not a repeat from the same agency.
