Disclosure Materials

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Issue Date	Ongoing
Topic	Labor Lawsuits
Summary of Issue	Labor suits against the company were filed by former employees, employees, and third parties relating, among things, to wrongful terminations, dual labor market disputes, accidents, and occupational diseases. Multiple cases mention MAXEM COOP DE TRABAJO. Bligraf SA contracted third-party subcontractors for productive services through a legally constituted workers' cooperative: MAXEM. There was no direct employment relationship with the people associated with said cooperative.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The cases involve ten individuals. Four of the cases pending were open prior to 2020, and are still pending. Ten claims are due to wrongful termination, and one relates to occupational diseases. The estimate around the financial implications for all cases sums at least 2.14% of the company's annual revenue.
Impact on Stakeholders	The primary impact related to any labor litigation related to a wrongful termination is a financial impact on former employees, employees, and/or third parties. When there is a dispute around the employee status of any worker in a company's daily operations, workers' rights and general well-being are affected. Occupational diseases impact workers' health and well-being directly.
Resolution	Ten pending cases relate to wrongful terminations, one pending case relates to occupational diseases, and one relates to the recognition of rights.
Management Practices	<p>The company terminated its contractual/production relationship with MAXEN. It was replaced with a different provider for high-demand periods such as Father's Day, Mother's Day, Children's Day, Christmas, and special releases.</p> <p>Bligraf S.A. implemented administrative audit and internal control procedures regarding service providers, including verifying payment vouchers for subcontracted labor and</p>



	controlling the tax situation of associates by reviewing payment vouchers for the monotributo and other applicable tax obligations.

Disclosure Questionnaire Category: Other Disclosure Industries

Bligraf is directly involved in the single-use plastics Industry, which is subject to stakeholders' criticism due to potential risks related to ESG aspects. Currently, B Lab does not have specific requirements for this industry; however, Certified B Corps are required to make transparent their involvement in such industry.

B Lab rationale for moving forward with certification:

- Bligraf began their recertification process after B Lab identified the Single-Use Plastics as an industry that may require further risk review.
- Bligraf meets the current minimum requirements, in which a company's product portfolio should be recycled or biodegradable.

As B Lab continues to evolve its standards and due diligence approach for this specific industry, the updated criteria will be shared with the company once they are finalized. The company will then be required to meet these new standards by their next recertification.
