



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Wild + Pine is an environmental reclamation company with major clients in Oil & Gas and Forestry Industries.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Wild + Pine performs environmental reclamation, and forest conservation, services to Oil & Gas and Forestry industries. Their focus is on restoring disturbed ecosystems, and they must produce project reports that are audited by federal and provincial governments. Reclamation projects for regulated industries require certification from the regulating body to be considered complete.
IMPACT ON STAKEHOLDER(S)	Wild + Pine's role as an environmental services provider is to restore and return disturbed land to an equivalent capability after industrial activity, as defined by provincial regulations. However their scope is not limited to regulated industries such as Oil & Gas and Forestry.
IMPLEMENTED MGT PRACTICES	Wild + Pine is operated by licensed professionals in Forestry and Agrology. Both professional designations require actions and decisions to be taken in the best interest of the public and the environment before the interests of clients, employers, or other corporate stakeholders. For work performed in regulated industries, all reports must be reviewed and approved by a designated industry professional with the above signing authority. The company performs the following services: - Reforestation and vegetation management; - Caribou habitat restoration; - Seed collection and production of native tree/shrub species; - Afforestation; - Infill Planting; - Reclamation of disturbed landscapes; - Sustainability planning including emissions modelling
