Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Putative class action alleging deceptive product-promotion practices.
Summary of Issue	A putative class action was filed alleging that FoodState engaged in false promotion of its MegaFood One Daily Multivitamin product as primarily consisting of and providing vitamins and nutrients from whole foods as opposed to synthetically created vitamins or processed extracts, and failure to disclose the presence and use of magnesium stearate.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The case was settled for an amount that was >5% of the company's revenue.
Impact on Stakeholders	The main potential risk for consumers is being misled by inaccurate or incomplete product ingredient and sourcing information.
Resolution	The parties settled the matter with FoodState paying the agreed-upon settlement sum.
Management Practices	The Company modified product labels and website presentations.
