Disclosure Questionnaire Category: Recalls

Instinctus Co., Ltd. reported conducting 1 mandatory recall in the past five years, representing 11% of the company's products for the same period. When a product is recalled, various stakeholders such as customers, suppliers, investors, commercial partners, and local communities may face negative impacts, including health and safety risks, financial losses, loss of trust, damage to credibility, and other inconveniences. Disclosure Questionnaire Category: Animal Testing

Topic	Company is required to undergo mandatory animal testing by law.
Summary of Issue	Instinctus Co., Ltd. is a personal care company that produces lubricants that are required to be tested on animals by law in the markets where they operate. The testing was outsourced to third-party institutions.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	3.61% of the company's products underwent animal testing.
Impact on Stakeholder(s)	Animal testing and experimentation is widely used to develop new personal care products and to test the safety of other products. Many of these experiments can cause pain to the animals involved or reduce their quality of life in other ways.
Implemented Management Practices	<p>The Korean Ministry of Food and Drug Safety (MFDS) legally requires animal testing for sensitization and irritation/intradermal reaction testing for personal lubricants. Instinctus Co., Ltd requested to MFDS to utilize international test standards and alternative non-animal methods; however, none were accepted. The animal testing for its product was conducted only once at the initial approval stage.</p> <p>The company periodically monitors whether its customer services team receives inquiries, concerns, or reports related to animal testing. When such inquiries arise, they are immediately shared internally to verify the facts and determine whether improvements are needed. If issues related to animal testing emerge—through customer questions, certification outcomes, or supplier checks—the company documents them and takes corrective actions, such as updating product page notices or revising FAQs.</p> <p>Animal testing is performed only by Good Manufacturing Practice (GMP)-certified external testing institutions that follow MFDS-designated protocols; the company's own internal ethical standards are not permitted as substitutes under the regulatory framework.</p>

	<p>The laboratory engaged by the company operates under the supervision of the appropriate governmental regulatory authority responsible for overseeing animal experimentation (e.g., CCSEA), and it was subsequently confirmed that testing was conducted within a framework aligned with internationally recognized animal welfare standards, including those associated with Association for Assessment and Accreditation of Laboratory Animal Care (AAALAC). These external regulatory and accreditation systems serve as key mechanisms to ensure the ethical and lawful conduct of animal testing.</p> <p>Monitoring of animal testing processes is not performed directly by the company, but is instead based on reliance on the laboratory's accreditation status, mandatory regulatory inspections, and its obligation to comply with applicable local laws and internationally recognized standards.</p> <p>Instinctus Co., Ltd pursues and maintains vegan certification (KVCS) for relevant products, including verification that no ingredients or components involve animal testing. The company's broader practices align with principles of replacement and reduction by actively seeking and supporting alternative methods and limiting animal testing only to legally required medical device tests.</p>
