



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Significant layoffs of >20% of workforce
ISSUE DATE	August, 2018
TOPIC	Significant layoffs due to the restructuring of the business because of a decrease in sales(clients) and loss of turnover by 45%
SUMMARY OF ISSUE	In August 2018, the company lost roughly 45% of its business due to the loss of three clients. This necessitated employee layoffs
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	3 employees were laid off, representing 33% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	The CEO communicated this issue to the individuals involved personally and the company paid them severance and offered counseling as they were understandably upset and also offered them help with resources. No one accepted help but no legal action occurred. All three of those affected by laid-offs have found new jobs quickly, in about a month after the lay-offs.
