



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Significant layoffs of >20% of workforce
ISSUE DATE	December 2017
TOPIC	Significant layoffs due to loss of client
SUMMARY OF ISSUE	In 2015, Bohlsen Group lost a large client and had to lay off a large amount of staff. Since Bohlsen Group was still feeling those implications in 2017, the company had to lay off more staff at the end of that year to maintain a workable financial status.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	13 employees lost in 2015, which represented 42% of the workforce at that time. 4 employees lost in 2017, which represented 27% of the workforce at that time.
IMPACT ON STAKEHOLDERS	The primary stakeholder impact was loss of employment and salaries for several Bohlsen Group employees.
IMPLEMENTED MGT PRACTICES	Employees who were laid off were given a six month notice with a tiered departure in which work load was reduced. Bohlsen Group staff actively helped laid off workers find jobs.
RELATED INCIDENTS (YES/NO)	The company had a previous layoff in June through December 2015.
