Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	Feist Hedgethorpe Limited, trading as Plus Accounting, is a firm of chartered accountants that offers accountancy services related to UK tax issues. These services include Enterprise Investment Schemes and Seed Enterprise Investment Schemes, Enterprise Management Incentives, Employee Ownership Trusts, Capital Gains Tax, Inheritance Tax, Trusts and personal tax planning
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Tax compliance work is an essential and interlinked part of the overall service the company offers, and 100% of the company's revenue comes from these accounting services.
Impact on Stakeholders	B Lab recognizes payment of due taxes as a material business issue and has a Framework for Evaluating Tax Strategies for B Corp Certification. Given ETASL's limited scope of tax-related services for the UK and US tax systems only, its services are consistent with the principles that (1) the amount of overall taxes paid over time appropriately reflects the actual amount of income generated by ETASL's clients, and (2) the amount of taxes paid over time in each jurisdiction appropriately reflects the actual operations of the client in that jurisdiction.
Implemented Management Practices	The company provides a "tax-saving strategy" as part of their services; however, they do not offer services that aim to minimize tax bills through aggressive tax avoidance. As a direction to their staff, they cannot provide advice that results in aggressive tax avoidance. The company is accredited under the ICAEW (ICAEW Chartered Accountants, accountancy firms, students and regulated and affiliated individuals) and follows the code of ethics of The Institute of Chartered Accountants in England and Wales. Additionally, the company provides training to their team related to Anti-Money Laundering
