Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

IMPACT ON STAKEHOLDERS	The standard of care animals receive have a direct impact on their health and wellbeing. The treatment of animals, for example, the unnecessary administration of antibiotics, can also have an impact on the health of consumers.
IMPLEMENTED MGT PRACTICES	"Ossa Organic only buys organic certified and grass fed ingredients to organic OF&G Certification and Soil Association Organica (British Standards).  The company's standards are the highest with regards to no antibiotics, outdoor and organic as certified under OFG and Soil Association standards and all animslas are signed off by a VET. The company sources antibiotic free animals for their supply ensuring that their farm suppliers adhere to OFG and Soil standards. The company does not publicly report on their sustainable impact.
