



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

The company aims to collaborate to the goal of offering more affordable and cleaner energy solutions. The company helps their clients achieve decarbonization in four ways: Supply: Utilities are adding more zero-carbon sources of energy to allow for the reduction in use and eventual retirement of fossil fuel electricity production. Uplight can help increase customer uptake of these renewable energy sources. Conservation: Utility programs help end users replace inefficient buildings technologies, appliances, and usage with enhanced technology and efficient consumer behavior. Uplight provides technologies and programs that both directly and indirectly reduce end-customer energy use. Electrification: Utilities are actively replacing fossil fuel consuming devices, equipment, and transportation with electric replacements, which can use the increasingly clean electric supply. Uplight provides technology that helps accelerate adoption of these electrified replacements. Enabling technology: The changes above also require utilities to manage a changing electrical load shape on the grid and to accommodate the more variable generation typical of renewables.
