TOPIC	GOODEE has Tier 2 suppliers in Burkina Faso in order to support artisans in conflict zones.
SUMMARY OF ISSUE	<p>GOODEE sources raw material from conflict zones and low income areas to enable economic empowerment in such areas. Specifically, the company purchases woven textiles (fabrics) produced by local female artisans through a network of social enterprises in Burkina Faso.</p> <p>Parts of Burkina Faso have seen a humanitarian crisis in recent times owing to violent attacks by extremists in the Sahel region. Consequently, almost one third of the country is now a conflict zone.</p>
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Almost 12% of GOODEE's spend on suppliers in 2018 was to enable purchases from Burkina Faso.
IMPACT ON STAKEHOLDER(S)	As per the OECD, conflict zones are often characterized by widespread human rights abuses and violations of national or international law.
IMPLEMENTED MGT PRACTICES	<p>GOODEE's aims to create not just premium products, but also stable, dignified work, and creative and resilient women, men and communities.</p> <p>GOODEE's tier 1 suppliers work directly with the Ethical Fashion Initiative to improve working conditions and raise workers living standards through payment of living wages, enforcing anti-harassment policies, and enforcing no underage or forced labor policies. Ethical Fashion Initiative (EFI) is a flagship programme of the International Trade Centre, a joint agency of the United Nations and the World Trade Organization.</p>
