

DISCLOSURE MATERIALS

- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	As a vineyard and winery, A to Z Wineworks operates in an industry in which biodiversity impact and monoculture agriculture are material environmental issues.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 100% of A to Z Wineworks' revenue was earned from the sale of wine 100% of the company's vineyard land is cultivated. A to Z Wineworks' controls other land used for manufacturing and as a tasting room.
IMPACT ON STAKEHOLDERS	Agriculture, particularly in cases where a single crop is cultivated at a time, poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land.
IMPLEMENTED MGT PRACTICES	A to Z Wineworks' winery is LIVE certified and also sources grapes from other LIVE certified growers. LIVE supports environmentally and socially responsible winegrowing through third-party certification and education. All LIVE members are required to maintain ecologically rich areas on their farms. These include swaths of wildflower meadows, dense rich hedgerows, forested stands of trees, and protected riversides. All pesticide use is monitored and approved through the LIVE program. The company also performs in-row cultivation around the vines each spring through discing.

SUMMARY OF ISSUE	As a vineyard and winery, A to Z Wineworks operates in an industry that is water intensive. Aspects of the industry that make it water intensive include irrigation used in the cultivation of vines, water used in the winemaking process (e.g. for cleaning tanks and barrels), and water used in the bottling process.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 100% of A to Z Wineworks' revenue was earned from the sale of wine The company does not use irrigation for the grapes. All grapes are dry farmed.
IMPACT ON STAKEHOLDERS	As water intensive industries, agriculture and wine production poses risks such as water stress or depletion of local water sources if water use is not appropriately managed.
IMPLEMENTED MGT PRACTICES	A to Z Wineworks is a certified LIVE vineyard. As LIVE members, the company dry farms their wine grapes. All other grey water at the winery is sent to a settling tank through the drain system, it is filtered and then sprayed on the non-farmed land as irrigation.

All employees are licensed through the Oregon Liquor Control Commission (OLCC) which includes a multiple hour training session and test that must be passed. Recertification is required every few years. This training also includes service to minors. A to Z Wineworks also follows all advertising rules for media and on the company's website. The company promotes alcohol with food, with friends & family, and in moderation.
