Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	Great Place to Work conducts employee research, the Trust Index survey, to assist organizations in understanding and improving their organizational culture for their employees. Over the last 5 years, the company has served clients operating in the Bottled Water, For-profit Higher Education, Fossil Fuels (coal, oil sands) and Gambling industries. The company's service can be sold to clients in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In FY2023 clients operating in controversial industries represented the following % of the company's revenue: • Bottled Water: 3.09% • For-profit Higher Education: 0.75% • Fossil Fuels (coal, oil sands): 0.81% • Gambling: 0.80% • Marketing of Breastmilk Substitutes: 0.30% • Pharmaceuticals: 2.37%
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	In deciding to work with clients in sensitive industries, Great Place to Work have shared that they aim to strike a balance between supporting customers in diverse industries to improve their organizational culture and become a Great Place To Work for their employees and avoid working with organizations that are willfully incompetent or significantly harm people or the environment.
