Summary of Issue	Adviso Partners is a financial advisory company that has had clients in the bottled water, fossil fuels, Pharma and Defense industries. The nature of the company's services with clients in these industries has been related to M&A, all services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients the Bottled Water industry represented 14.02% in FY21-22 The revenue from clients the Defense industry represented 3.41% in FY21-22 The revenue from clients the Fossil Fuel industry represented 0.26% in FY21-22 The revenue from clients the Pharmaceuticals industry represented 1.26% in FY21-22
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company's validation committee does due diligence before engaging with new clients to look at the client's sectors of activity and environmental and societal criteria. The company does not work with the following sectors: Tobacco, Adult content, Controversial weapons, Narcotics, Gambling/casinos, Toxic substances for the environment and human health, Pesticides, Deforestation, Palm oil, GMO, Animal testing. The company has a business committee to evaluate clients taking into account in particular the sector of activity. The company identifies client or beneficial owner by collecting information, proof of identity and assessing risk of money laundering and terrorist financing.

The company's clients need to follow the clause: "The Shareholders and the Company declare that they have complied with the regulations on the fight against money laundering. They declare that they have not provided any assistance in a placement, concealment or conversion operation of the direct or indirect proceeds of an offense, and that they have neither contributed to, nor facilitated by any means, the false justification of the origin of the property or income of the perpetrator of an offense."
The company does not serve clients in the Defense Sector anymore.
