Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	Mataro Advice provides promotional textile, merchandising, and workwear to corporate clients. The company has had clients in the alcohol industry which is deemed a controversial industry by B Lab. The services offered to clients in this particular industry relates to providing clothings and other promotional goods such as notebooks, pens and mugs. The products provided to the clients can be sold to other clients in different industries, including other both non-controversial and controversial industries, although it is tailored from client/industry to client/industry.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year end of 2024, the company had generated 2% of its total revenue from clients in the alcohol industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Mataro Advice evaluates all potential clients, particularly potential clients in sensitive industries such as tobacco, alcohol, gambling, fossil fuels, defense, and adult entertainment, to ensure they meet the Mataro's ethical standards. To mitigate potential risks related to its potential clients/current clients, Mataro Advice has implemented an Ethical Sourcing Policy to ensure products are sourced ethically, even within

	controversial industries, reducing the risk of association with unethical practices. The company practices a Transparent Supply Chain - transparency in the entire supply chain, from sourcing to distribution, to ensure compliance with ethical standards and minimize the risk of inadvertently supporting unethical activities. Mataro Advice conducts regular audits and due-diligence checks on its suppliers and partners within the controversial industry to identify and address any ethical or compliance issues promptly. Furthermore, they actively engage with industry watchdogs, NGOs, and regulatory bodies to stay informed about potential risks on certain industries and take proactive measures to mitigate them. The company transparently communicates with customers about the steps taken to mitigate risks associated with the controversial industry.
