Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Issue Date	2019 - 2024
Topic	Labor Disputes, Consumer Accessibility Claims
Summary of Issue	The Company faced a combination of labor and consumer legal matters. On the labor front, four matters were reported involving four separate stakeholders. These included claims of harassment, discrimination, retaliation, wrongful termination, and wage-and-hour violations. One notable ongoing case is in litigation and involves a former employee who was part of a Company-wide layoff alleging claims of harassment, discrimination, and wrongful termination. On the consumer front, two lawsuits were brought claiming the Company's website was not accessible to individuals with disabilities, in violation of the Americans with Disabilities Act (ADA), New York State and City Human Rights Laws, and California's Unruh Civil Rights Act. Both of the consumer cases have been resolved.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The total financial value associated with these cases represented less than 1% of the company's annual revenue.
Impact on Stakeholders	The labor claims directly affected at least four former employees who alleged claims related to their employment and/or their termination. The consumer claims involved a broader stakeholder group of 24 individuals and related to digital accessibility barriers on the Company's website.
Resolution	Two labor claims and both consumer accessibility cases were resolved. Two other labor claims remain pending.
Management Practices	The Company continues to strengthen its internal procedures for managing performance concerns, terminations, and layoffs. This includes engaging legal counsel early to assess risk and ensure documentation is thorough and compliant. The Company also implemented improved tracking of final wage payments, especially when using non-employee production vendors. To improve consumer accessibility, the Company involved its Digital Leader to increase awareness and oversight of website accessibility design, ensuring leadership is informed

	and that accessibility is taken into account in future digital initiatives.
