Summary of Issue	GDS Communication S.r.I provides marketing and communications services. The company is working with the pharmaceutical industry and their marketing service includes disease awareness campaigns, surgical videos and live surgery, medical affairs and compliance.
	The company is not involved in R&D, manufacturing or Direct Sales of pharmaceutical products. GDS Communication S.r.l is not involved with lobbying and policy advocacy, intellectual property strategies, prices gouging and unjustified year over year price increases.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the 2023 fiscal period, 76% of the company's annual revenue derived from the pharmaceutical industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. As a company involved with the Pharmaceutical Industry, B Lab requires the company to have in place policies and practices in relation to the interaction with healthcare professionals/organizations, ethics, anti-corruption and bribery, lobbying and advocacy.
	Companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	GDS Communication has a Code of Ethics that includes the following topics:  o Anti-corruption and bribery, o Lobbying and advocacy activities, o Company interactions with healthcare professionals/organizations, o Ethical marketing



	This Code is applicable to all company employees and key suppliers. To ensure adherence to the above policies, the company's management periodically reviews the suppliers' conduct, in addition to offer access to a whistleblowing channel, and regular training on the Code.  The company's clients are companies with sustainability reports and ethical standards confirmed by certifications and codes of conduct.
Management Comments	The company has the ISO 14001: 2015 (standard for an effective environmental management system) and ISO 9001: 2015 (Quality Management System) certifications. In 2024, GDS Communication also achieved the ISO 30415: 2021 (Human Resources Management – Diversity, Equity and Inclusion) validation and the Uni Pdr 125 Certification on gender equality.
