Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Issue Date	Dec-22
Topic	Litigation, Arbitration, and/or Penalties related to termination of supplier contract.
Summary of Issue	PHENIX terminated a vehicle rental contract. The supplier started a litigation against PHENIX to obtain the termination compensation. The case has been settled and closed.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	PHENIX SAS agreed to pay approximately 1/3 of the sum claimed, which is less than 0.01% of the company's turnover.
Impact on Stakeholders	The stakeholders affected were the Supplier and Phenix.
Resolution	The dispute was settled and the corresponding payment was made.
Implemented Management Practices	The company now has an internal legal department that reviews all supplier contracts in detail.
Related Incidents (Yes/No)	In 2020 Phenix was involved in another litigation related to the termination of a supplier contract, due to misconduct. the Paris Commercial Court dismissed all of the plaintiff's claims and ordered them to pay PHENIX SAS.
