

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	August and October 2022
TOPIC	Significant layoffs due to significant reduction in customer sales
SUMMARY OF ISSUE	"Significant layoffs due to the cost-of-living crisis in Europe impacting consumer purchasing. A higher proportion of customers cancelled or paused their flower subscriptions, or reduced how frequently they receive flowers, which reduced sales, and revenue to cover the company's costs. An initial round of structural changes and redundancies took place between August and October 2022.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	"The company experienced two rounds of layoffs which resulted in a total of 105 employees being laid off in 2022: In August, 32 employees were laid off, representing 8% of the company's employees at that time. In October, a further 73 employees were laid off, representing 24% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	"The company provided the following benefits and/or resources to affected employees in order to minimize potentially negative impacts of the redundancy: - Increased the notice period pay for affected employees in their probation period from one week to three weeks to reduce the financial impact. - Enhanced redundancy pay for affected employees with over two years service above the statutory cap (e.g. those with two years service received two weeks redundancy pay free from tax and national insurance at their standard salary rate rather than with the cap). - Promoted the employee assistance programme as a resource for counselling and support as well as the company's dedicated counselling service via Mind Clinic.
