



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	OKA Direct has suppliers in Myanmar
SUMMARY OF ISSUE	OKA Direct is a furniture company. Part of their suppliers is based in Myanmar 2022. Myanmar has experienced political nature conflicts since early 2021. The situation was classified as a medium-intensity conflict by World Bank in 2022.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In 2023, approximately 0.2% of the company's expenses are with suppliers based in Myanmar.
IMPACT ON STAKEHOLDERS	As per the OECD, conflict zones are often characterized by widespread human rights abuses and violations of national or international law. The security of company workers who work in such areas could also be at risk. The company should also have mechanisms in place to not sponsor or promote any activities that could increase the widespread of human rights abuses and violations.
IMPLEMENTED MGT PRACTICES	OKA Direct works closely to their suppliers to build long term relationships in order to support transparency in their supply chain. All suppliers are required to sign a code of conduct committing to attain to OKA's ethical and sustainable standards and policies. The compliance with the code of conduct is also required from subcontractors and any out-workers engaged in OKA's supply chain. The company also conducts visits to its factories and, when possible, third-party social audits are also conducted.

MANAGEMENT COMMENTS	The Company is committed to third party SMETA audit of Myanmar based suppliers and plans a visit by member/s of the Senior Leadership team during 2023/2024.
