SUMMARY OF ISSUE	As a company that manufactures aerosol paint, Ambro-Sol S.r.l. SB operates in an industry in which chemical use is a material environmental issue. The company is based in Italy and sells different types of aerosol sprays.
	The aspects of the production process that are chemically intensive are the mixing of chemical raw materials to create aerosols products.
	The main chemicals used by the company are: propellants like LPG and DME, Solvents like Acetone, methyl acetate, acrylic resins, and pigments. The company doesn't use any Substances of Very High Concern (SVHC) under EU Reach Regulations.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 96.94% of the company's revenue was earned from the sale of its aerosol products.
IMPACT ON STAKEHOLDERS	As a chemical-intensive industry, paint and aerosol product production pose environmental risks such as air, land, and water pollution, as well as potential human health risks to those exposed to harmful chemicals.
IMPLEMENTED MGT PRACTICES	The company has committed to become carbon neutral by 2030 and net zero by 2050. In the company's R&D lab, they are developing new methods to produce aerosols without propellant and without solvents, which will make them free of chemicals and also zero emission. This technology is called BOV (bag-on-valve) where they use normal atmospheric air as propellant and natural raw materials like organic/bio ethyl alcohol as solvent, and lithium based products or water based products. They are aiming to use their BOV technology as soon as possible. As the company doesn't use any water in their manufacturing processes, they don't have wastewater. They use solvents for the cleaning of their machines and distillation for recycling the solvents. They carried out a certified company wide carbon footprint process. They are working on defining their carbon footprint per product by looking at the full LCA. They conduct training for their employers in every area of the company including the mixing process, which is partially mandatory by the Italian law. They also monitor every substance under their ISO14001 on an annual basis. In addition, they have implemented a distiller for recycling all of their solvents. They also utilise the DIY sector and encourage the reuse of materials to avoid waste and create a circular economy. The company has created a Youtube channel, link available below, with professional YouTubers to promote DIY projects. They have also commissioned a scientific study on DIY and LCA with their partner Thimus, the results of which will be ready at the end of the
