Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	The company's industrial plant in the city of Ypacaraí is located within the polygon of the Lake Ypacaraí Managed Resources Reserve and the Adjacent Wetland System, which is a protected wild area (preservation of Lake Ypacaraí and its adjacent wetlands, its biodiversity, and functionality as a provider of ecosystem services), as the city of Ypacaraí is located in the buffer zone of this reserve. This reserve is recognized by the Ministry of Environment and Sustainable Development of Paraguay (MADES) and the Paraguayan state through Law No. 5,256 - Which declares the Lake as a protected wilderness area of public and private domain with the category of management reserve of resources managed by the Lake Ypacaraí and the adjacent wetland system.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of the industrial facilities where 100% of the products are produced are located in this sensitive ecosystem. The commercial facilities are located outside of this zone
IMPACT ON STAKEHOLDERS	The possible environmental risks are related to the discharge of untreated solid and liquid waste into the water canals, which could result in the pollution of preserved water resources
IMPLEMENTED MGT PRACTICES	"The company has a water treatment system to ensure that no liquid waste is discharged into water canals and the solid waste is treated and disposed of according to high standards and with suppliers that have an environmental license. Besides, the company has an environmental management system certified by independent third parties under the ISO 14001 Standard and beyond the standard, it implemented some practices to enhance the preservation of natural resources, such as: Campaign to reduce the use of paper in an industrial plant, reducing carbon emissions and solid waste emissions Comprehensive treatment of wastewater with constant monitoring of emission values Employee awareness campaign on the importance of waste separation Composting of pruning remains and organic waste"
