Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	Speakers Corner (London) provides keynote speakers, motivational speakers, awards hosts facilitators and after dinner speakers/comedians for corporate events. The company has provided its services to clients in the Pharmaceutical and Fossil Fuel industry over the past 5 years. The role of the speakers is to provide education or inspiration to the respective audience and ensure the event runs smoothly; the service does not vary for companies in controversial industries and non-controversial industries, although speakers adapt to the purpose of the event.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Over the past 5 years, a total of 1.71% of Speakers Corner's revenue was derived from clients in controversial industries: 0.73% from clients with a link to the fossil fuel industry 0.98% from clients in the Pharmaceutical industry
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Speakers Corner (London) carries out due diligence to ensure that its services are not used to harm people or the environment, by ensuring that the client understands the speakers represent their own views and that they do not endorse the client in any way. Speakers where appropriate take positions which may challenge businesses. The company does not have a position on working with clients in sensitive industries, nor aims to move away from potentially sensitive industries, however as the speakers do not represent or endorse the sensitive industries in any way, the company
