- 2) Describe how the company has addressed this issue.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Moorhouse Consulting provides management consulting services (such as delivery & performance, people & change, digital & data, strategy & costumer, and sustainability services) for clients in the fossil fuel, pharmaceutical and defense industries.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the FY21/22, 4% of the company's revenue came from the fossil fuel industry, 22% from the pharmaceutical industry and 5% from the defense sector.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
IMPLEMENTED MGT PRACTICES	Moorhouse work with pharmaceutical and life sciences clients to shape the future of the industry and transform health outcomes globally.
