Topic	Company serves clients in Controversial Industries
Summary of Issue	Broota is a entrepreneurship network with a crowdfunding platform that funds entrepreneurs through Equity Based or Investment Crowdfunding. The company has had clients in the Cannabis-related products (excluding recreational marijuana) industry and Pharmaceutical industry. The services provided to the clients relate to providing crowdfunding services. The services and products offered to clients can be equally provided to various industries, both controversial and non-controversial. The solution has not been designed exclusively for a specific sector, but is adaptable and applicable to a variety of contexts. This enables Broota to offer its expertise and products to a wide range of clients in different industries, ensuring flexibility and scalability in its application.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year of 2024, 5.98% of the client revenue has been from clients in the Cannabis-related products industry and 7.68% of revenue has been from clients in the Pharmaceutical industry.
Impact on Stakeholders	Companies that offer products/services to clients in controversial industries may be contributing to the controversial impact of those industries.
Implemented Management Practices	Broota currently does not have a formal position on working with sensitive industries or a policy to move away from them. The company affirms that although they operate in sectors that may be perceived as controversial, they strive to maintain a responsible and ethical approach in all of their activities. The company's risk assessment process ensures that any project or client they work with is subject to rigorous analysis to mitigate potential negative impacts, both for the company and for society in general. The company has a dedicated risk management committee, which is responsible for carrying out thorough assessments and

	due diligence processes. This committee also oversees the regulatory compliance framework, conducts regular audits and applies rigorous internal controls. In addition, a detailed assessment of each client is carried out, including active research into the industry in which it operates, with the aim of identifying and mitigating any potential risks related to its controversial nature. On the investor side, the company has a software that alerts them if any of them are on a sanctioned list.
