



## DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

<b>SUMMARY OF ISSUE</b>	Demers Beaulne provides tax advisory services related to due diligence work in the case of business acquisitions and assistance in assuring that all Canadian tax laws with respect to transborder transactions are respected. Their advisory services are for local tax compliance purposes.
<b>SIZE/SCOPE OF ISSUE</b> (e.g. \$ financial implication, # of individuals affected)	These services account for 18% of the company's revenue. The company works almost exclusively with SMEs and individuals.
<b>IMPACT ON STAKEHOLDERS</b>	B Lab recognizes fair payment of taxes as a material business issue and has a Framework for Evaluating Tax Strategies for B Corp Certification. Given Demers Beaulne scope of tax-related services in Canada only, its services are consistent with the principles that (1) the amount of overall taxes paid over time appropriately reflects the actual amount of income generated by the client, and (2) the amount of taxes paid over time in each jurisdiction appropriately reflects the actual operations of the client in that jurisdiction.
<b>IMPLEMENTED MGT PRACTICES</b>	<p>They do not offer any services, for either individuals or companies, that offer solutions to reduce tax, like for example offshore tax planning. They risk assess every client that they deal with and would not work with any client that was attempting to evade tax.</p> <p>Their tax services involve explaining the relevant rules and highlighting the various options available to their clients as part of their broader compliance work.</p>
