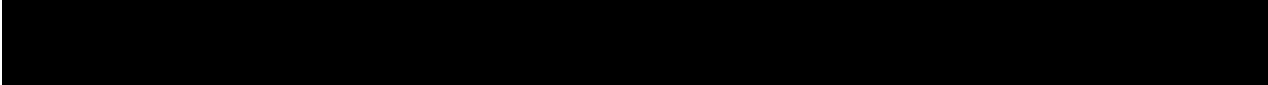

Topic	Company has suppliers located in Conflict Zones
Summary of Issue	<p>Onibus Coffee is a Japan-based specialty coffee roaster. The company visits producers and suppliers in origin countries to select green coffee and negotiate purchase volumes. Import procedures and logistics are managed by third-party importers, and the company pays service fees for these arrangements.</p> <p>Some of the company's coffee is sourced from Ethiopia, El Salvador, Guatemala, and Honduras, which are listed as conflict zones in FY25 List of Fragile and Conflict-affected Situations and Global Conflict Tracker.</p> <p>The company reported that sourcing options are inherently limited due to the small number of major coffee-producing countries. As a result, it continues to purchase from certain origins where it can secure the required quality and volume, maintain relationships with reliable exporters, and support on-the-ground visits and sourcing development.</p>
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	<p>In the last fiscal year, the following percentages of total green coffee purchases (by weight) came from each conflict zone:</p> <ul style="list-style-type: none">- Ethiopia: 24.2%- El Salvador: 1%- Guatemala: 20.6%- Honduras: 8.3%
Impact on Stakeholder(s)	<p>Business activities located in conflict zones are considered high-risk as they are more likely to cause or contribute to the conflict and/or sociopolitical instability.</p> <p>Countries classified as conflict zones are more likely to have a weak rule-of-law or a corrupt judicial system, which could undermine the effectiveness of operational grievance mechanisms for these businesses and their suppliers. In addition, the safety of the company's workers and other potential human rights violations are at risk.</p>
Implemented Management Practices	<p>During visits to origin, the company engages in direct dialogue with local suppliers and also maintains communication through importers. When suppliers visit Japan, they occasionally visit</p>



the company, contributing to the development of ongoing relationships. Suppliers have shared information about their support for producers and seasonal workers, including education and financial assistance, as well as community engagement activities.

Topics related to conflict have not arisen in these exchanges, and the company is not aware of any direct involvement of its suppliers in conflict-related activities.
