



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Biova Srl is a company based in Italy that earns a material amount of revenue from the sale of alcohol
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 95% of Biova Srl revenue was earned from the sale of alcohol - mainly beers
IMPACT ON STAKEHOLDERS	Alcohol may have a negative impact on the health and well-being of individuals and their communities
IMPLEMENTED MGT PRACTICES	Biova Srl is a company based in Italy that earns 95% of their revenues from the sale of alcohol - B2B and online. In recognizing the damages of alcohol, they are currently testing and working on non-alcoholic products (such as snacks, cookies and pasta) and plan to reduce the percentage of alcoholic driven sales from 95% to 50% over the next year. Biova is attentive in communicating the risk of alcohol to its customers: company's communication always include the disclaimer to drink responsibly and forbidden to underage (18 years old) individuals. In addition, Biova has a disclaimer at the entrance of their website, which asks users to declare their age before continuing to the main page. Biova is working to insert in their training procedure best practices for employees who work with public, to mitigate selling alcohol to minors.
