Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Industries at risk for human rights violations

Topic	Forced labor and human rights violations are recognized as material issues in the jewelry industry.
Summary of Issue	Lover's Tempo Design Inc. sells jewelry plated in precious metals. Precious metals material supply chains are generally recognized as posing a human rights risk. Lover's Tempo Design buys products from suppliers in South Korea and China. While the company does not directly source semi-precious stones, gold, or diamonds, its suppliers provide materials that have gold in them (like electroplating solutions or stainless steel alloy that contains gold). These suppliers supply the finished product and do not have a direct relation to the process of sourcing/mining for gold.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Approximately 95% of the products sold by Lover's Tempo Design are jewelries. From these, 37% are made in China, and around 63% are made in South Korea.
Impact on Stakeholders	The use of precious metals poses a human rights risk due to the possibility that they are sourced from conflict-affected and high-risk areas, where they may be used to finance conflict and/or be associated with human rights abuses in the supply chain. Specifically, the mining sector has a high potential for human rights abuses given the elevated risks of fatal accidents, abusive labor practices, discrimination against women, and environmental pollution and degradation.
Implemented Management Practices	All of Lover's Tempo Design's suppliers requires suppliers are required to adhere to a Code of Conduct and sign an agreement that includes minimum compliance requirements regarding child labor, forced labor, and conflict minerals, as well as requiring its suppliers to adopt a management system to ensure compliance with the Code. Its supplier, based in China, offers documentation of the materials sourcing. Their silver refiner supplier is listed on the LBMA's (London Bullion Market Association) Good Delivery

	List. The suppliers based in Thailand are also certified members of the Responsible Jewelry Council (RJC). As for the suppliers based in South Korea, they outsource the casting and the plating of the jewelry they produce. Currently, Lover's Tempo Design founder works closely with the South Korean suppliers to review the plating partners standards and certifications to ensure full visibility into the supply chain. The suppliers from this region have provided gold certifications and certificate of origin for the gold materials.
