SUMMARY OF ISSUE	North Coast Organics sells CBD Pain Stick Rub and CBD Full Spectrum Oil with less than .0746% concentration on a dry weight basis based on lab testing. CBD is a non-psychoactive compound derived from hemp. The company sources these products from the state of Oregon.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Products containing CBD constituted 0.18% of the company's revenue in 2018.
IMPACT ON STAKEHOLDER(S)	Current regulations governing the legality of cannabis-derived products are complex in the United States due to different layers of federal, state, and local laws. Thus, the legal landscape around such products, particularly CBD, is somewhat ambiguous at this time. There are many companies that do sell legally CBD products, which are designed to be non-psychoactive. While the risk of criminal prosecution may be low or negligible, B Lab encourages consumers, retailers, and manufacturers to conduct their own research based on individual circumstances to determine the legality of certain cannabis-derived products in one's jurisdiction.
IMPLEMENTED MGT PRACTICES	North Coast Organics abides by all relevant regulations in the production and sale of cannabis or cannabis-derived products. CBD related products are tested for levels of THCA, delta 9-THC, CBGA and CBD contents at a third party lab everytime the company receives a shipment. The company receives the breakdown of these levels and confirmation from the supplier that the products received contain a level of THC below 0.3%. The results are kept on file and are available to any consumer or inspector that asks for them. In addition there is a QR code on all company products that contain CBD. CBD related products are sold as per the provisions of Indiana State laws. North Coast Organics does not make or sell any medicinal or recreational marijuana products.
