- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	In 2017, a putative class action was filed against Foodstate based on allegations that FoodState engaged in false advertising. Foodstate denied and continues to deny that it engaged in false or misleading advertising. The parties settled the matter in 2018.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The case was settled for an amount that was less than 3% of the company's revenue.
IMPACT ON STAKEHOLDERS	No additional stakeholders were affected to the company's knowledge.
RESOLUTION	The parties settled the matter with FoodState paying the agreed upon settlement sum.
IMPLEMENTED MGT PRACTICES	FoodState, Inc. dba MegaFood's claims principles are: 1.) Do the Right Thing. This means putting the consumer first. 2.) The company does not violate the law and monitors FDA, FTC, States and other regulatory bodies to ensure that they are following all applicable requirements. 3.) The company always evaluates whether there is litigation risk and considers not only the financial cost, but also possible damage to the Brand reputation. All claims are evaluated against these three principles. No claim will be approved for use unless it is adequately substantiated by qualified experts. MegaFood has a Nutrition Science team of two PhDs and four Regulatory professionals with more than 75 years of combined technical expertise. Claims, marketing and labeling are reviewed, approved and managed from substantiation to execution in a cloud-based system that is our single source of truth with end to end traceability - from formula to advertisement.
