Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Suppliers in Conflict Zones

Topic	LOOM purchases products produced in Mexico, which can be considered a conflict zone.
Summary of Issue	LOOM Imports is a US retailer that provides Home Goods mostly supplied by artisans. It purchases finished goods of woven wool and cotton pillowcases, rugs, blankets, and home decor. The company has suppliers in Mexico, specifically from Mexico City and Oaxaca. Mexico is flagged as a region of concern by the Global Conflict Tracker. For the company's suppliers from whom it purchases finished products from all tiers of its supply chain are within Mexico. The country has a renowned reputation and history of handmade art and craft.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In 2021, the majority of LOOMs inventory was sourced from producers in Mexico.
Impact on Stakeholders	As per the OECD, conflict zones are often characterized by widespread human rights abuses and violations of national or international law. The security of company workers who work in such areas could also be at risk.
Management Practices	The company has implemented the following practices in the conflict zones from which they source: • LOOM uses the standards and practices of fair trade to base its partnerships and select its suppliers, • The company's owner visits suppliers in person to be able to audit both their workplaces and the safety and concerns of their local communities.
