Topic	Compulsory overtime
Summary of Issue	MVP Dairy is a dairy company that requires its manufacturing workforce to work between 48 - 65 hours/week. The shifts are organized as 3 days, 3 nights, 3 off or 6 days on, 1 day off.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Everyone except admin staff work more than 48 hours a week. Job hours are listed as 55-65 hours a week or parlor shifts are listed as 3 days, 3 nights and 3 days off—12 hour shifts.
Impact on Stakeholders	Working long hours can impact employees' quality of life. Among the risks are stress, fatigue, health and mental issues.
Implemented Management Practices	MVP Diary shared that all labor laws are posted in both English and Spanish in employee break rooms in easy sight. The company claims to adhere to all labor laws and regulations and are audited regularly by Validus through worker care certification to verify employees' safety and well-being. The company has completed mock audits and evaluations to compare their standards with other businesses locally and internationally for leading food companies. Hours, Wages and benefits are competitive and the leadership team has an open door policy to keep an open form of communication to address employee questions and concerns promptly. In addition to OSHAA trainings and standards, MVP Dairy also has animal handling trainings and worker care audits conducted by third party experts to ensure employees are safe doing their jobs. Also PPE is always provided. All employees also have access to company paid mental health counseling. They learn about this during onboarding and are reshared regularly in employee newsletters as a reminder. Every employee clocks in and out at the beginning and end of their work shift and is paid an hourly wage competitive with others in our region. Bonuses are also paid when appropriate considering key performance indicators.
