Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Facilities located in sensitive ecosystems

Topic	Company office is located in a town in a national park in the Argentine Patagonia region. Company also arranges tours to national parks too.
Summary of Issue	The company's office is located in the autonomous town of San Carlos de Bariloche which is in located in the Nahuel Huapi national park. The company's facilities are not located in the protected areas of the national park, however the company operates tours to the principal area of the national park as well as to the municipal park of LLao LLao. These areas have been designated as a national park and municipal park for the protection and conservation of a portion of the Andean north Patagonian forest and surrounding steppes and for promoting education, awareness of these ecosystems while encouraging harmonious integration of nature and human development.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	All land under management is located in the sensitive ecosystem. About 50% of the tours organized by the company are to the national park and the municipal park. 20% of the tours are organized in the steppes surrounding the parks.
Impact on Stakeholders	The facilities are located inside protected/sensitive ecosystems as well as the company provides services in these ecosystems and thus can potentially impact the flora, fauna and quality of the ecosystem.
Implemented Management Practices	The company currently has no certifications for the management of their impacts but are aspiring to certify under ISO21101 for risk management and subsequently will also apply for certifying under the Global Sustainable Tourism Council's (GSTC) standards. The company already uses the guidelines and objectives of the GSTC standards for designing their processes. Through the company's sustainability policy they list out the various initiatives that the company is undertaking, including mitigation and offsetting of carbon emissions, monitoring of water consumption, monitoring and reduction of waste at source with a specific emphasis on single use plastics and promotional paper products.
