- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

SUMMARY OF ISSUE	As a brewery, Upslope Brewing Company operates in an industry that is water intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscaly year, 99% of Upslope Brewing Company's revenue was earned from the sale of alcohol
IMPACT ON STAKEHOLDERS	As a water intensive industry, brewing poses risks such as water stress or depletion of local water sources if water use is not appropriately managed.
IMPLEMENTED MGT PRACTICES	At an efficiency of three barrels of water to one barrel of beer at the main production facility, the company has achieved "Best in Class" in water efficiency according to the Brewers' Association Sustainability Benchmarking data. The company's current target is to dial in water usage by process and incorporate that usage into standard operating procedures to prevent backsliding in efficiency over time. The company also works with the city of Boulder to ensure that its water use targets align with theirs. Upslope Brewing Company benchmarks water usage against other breweries within the size range using the Brewers' Association Sustainability Benchmarking Tool. The company's water comes from the headwaters of Boulder Creek and diversions from the Upper Colorado River on the Western Slope. The brewery's water use is non-consumptive in that it is returned to Boulder's water treatment plant. As such, it doesn't reduce the total water available in the city.

All tap room bartenders, sales representatives, and any other employees who serve beer on behalf of Upslope are required to be certified in Training for Intervention ProcedureS (TIPS). The company adheres to the Brewers' Association ethical marketing policy, practices strict IDing of consumers, and expenses Ubers or taxis for employees and customers who need them to prevent DUIs.
