Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	Jack Ryan is a marketing and branding consultancy and has had clients operating in the Fossil Fuel (other, excluding coal, oil sands) as well as the Gambling industry over the last 5 years. Services to these clients included media buying, planning and consultancy. In addition, services to the gambling client included consultancy in relation to safer gambling. Services offered by the company can be offered to companies in both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Revenue from this client in the current FY2023 represents 0.60%, reduced from 5% in FY2022.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Jack Ryan carries out background checks when considering potential clients that operate in sensitive industries including verification of applicable laws and licenses held in the operating markets. With regards to clients in the Gambling industry, the company also reviews with the UK Gambling commission for any fines or penalties against the operator. They have confirmed that they have never worked with a client that has had regulatory violations in protecting consumers from gambling harms. Jack Ryan has assisted their client's compliance team in a review of their safer gambling checks and have ensured that all regulatory requirements are met and have mandated as part of their partnership that the company spend 20% of their marketing budget in Safer Gambling Activity. The company does not currently have a position on working with clients in controversial industries.
