



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Making Cents International derives a part of their revenue from operations based in Ukraine.
SUMMARY OF ISSUE	"Making Cents International is a social entrepreneurship that provides services to local organizations to create inclusive and supportive social and economic ecosystems. Part of their operation is based in Ukraine. Ukraine has been in conflict with Russia since 2014. In 2022 the war escalated. Ukraine is classified as a conflict-affected zone by World Bank in 2022."
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company derived 5% of its revenue from projects in conflict affected areas in 2021.
IMPACT ON STAKEHOLDERS	"As per the OECD, conflict zones are often characterized by widespread human rights abuses and violations of national or international law. The security of company workers who work in such areas could also be at risk."
IMPLEMENTED MGT PRACTICES	Making Cents abides by a code of conduct and set of business practices that ensures transparent procurement of goods and services locally. Their local staff receive generous benefits and are covered under the security umbrella of Making Cents' clients, which provides them with information related to any security and safety threats. Making Cents also has develop an internal crisis management plan that directs their response to any security threats related to conflict and staff endangerment.
