Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	Loom Digital is a digital marketing service provider. The company has had clients from the fossil-fuel (non-coal/oil sand) business which is deemed to be a controversial industry by B Lab .
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year of 2023, an estimated total of 5.3% of revenue was generated through the clients in the above mentioned controversial industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Loom Digital is not looking for new clients in the fossil fuel space and will not work with a competitor to its current client in the fossil fuel industry. The current client of Loom Digital is involved in the storage of fossil fuels and renewable fuels, and is not involved in the production process. The company has active engagement with the stakeholders of their client to understand the business impact and future direction to monitor impact. Loom Digital also reviews the client's annual report. Loom Digital would decline prospective clients who are operating in controversial industries and clients that do not fit the company's values which are; (good) Citizen, Connected, Collective, Confident. The company screens prospective clients through early conversations to understand if the client would fit with the company's values and aspirations to be in the BCorp community. Loom Digital also consults with its internal team



	members and takes into consideration any concerns or objections in deciding to take on a new client.
