This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	GloryBee sells honey and hive products that that are sourced from animal farms and beehives
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the 2020 fiscal year, 40% of the Glory Bee's Supplier expenditures come from animal farms and 29.6% of sales came from the sale of honey
IMPACT ON STAKEHOLDERS	As long as the bees and their hive are kept free of parasites, pathogens, and pesticides in the process of them making and beekeepers harvesting this honey, the bees won't be harmed. However, if products are not harvested in a sustainable manner, it coud negatively impact the health of the animals the products are sourced from.
IMPLEMENTED MGT PRACTICES	GloryBee is True Source Certified, which requires high standards for beekeeping and honey management and tracking. True Source Certified® is a voluntary system of traceability and authenticity testing for those participants who wish to demonstrate through an independent third party that their sourcing practices are in full compliance with U.S. and international trade laws. SUMMARY OF ISSUE	GloryBee is a provider of honey and natural ingredients to food manufacturers. The majority of the company's ingredients are agricultural products (honey, nuts, seeds, oils, grains), and GloryBee does not have control over how the products are grown/Harvested
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the 2020 fiscal year, 40% of the Glory Bee's Supplier expenditures come from animal farms and 29.6% of sales came from the sale of honey
IMPACT ON STAKEHOLDERS	Agriculture poses a risk to the flora and fauna of local ecosystems as well as the potential degradation of cultivated land.
IMPLEMENTED MGT PRACTICES	Glorybee asks all of their suppliers a series of questions about their beekeeping practices, and the land on which their hives are kept. Glorybee also conducts in-person audits with new suppliers and uses a supplier code of conduct which screens for product environmental sustainability, quality, saftey, and ethical practices. They support organic and non-GMO agriculture and strive to have a majority of their ingredients (60-75%) be organic and non-GMO certified. Glorybee's SAVE the BEE Initiative has raised and contributed \$850,000 to research on honey bee health and nutrition, creation of native pollinator habitat, and pesticide reform all of which have a positive impact on biodiversity in the Pacific Northwest.

SUMMARY OF ISSUE	In 2019, The FDA reported that two random surveillance samples of GloryBee Orange Blossom Honey tested for the presence of the antibiotic fumagillin residue. As a result, the honey was recalled
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the 2019 fiscal year in which this incident occured, this recall presented close to 3% of products. (536, 6 pack cases of 18 oz honey jars)
IMPACT ON STAKEHOLDERS	Fumagillin is toxic to red blood cells in vitro at concentrations greater than 10 μM.
IMPLEMENTED MGT PRACTICES	GloryBee uses a risk-based matrix aligned with scientific reports for antibiotics according to country, region, and historical data. They ask their beekeepers to sign an affidavit stating what feeding and treatments they use in beekeeping. Glorybee asks their beekeepers to monitor their honey for residue levels. This particular antibiotic is no longer in use in beekeeping.
