

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	"Late is a company based in Chile that sells household products including bottled water. The company receives bottled water from two suppliers: one supplies 20L bottles, and the other supplies 500cc water bottles. Because Late was a certified B Corp when B Lab published the Bottled Water statement, the company has one full recertification cycle to meet the Bottled Water standards. For the current recertification, Late shared a Strategic Plan to meet the Bottled Water standards by their next recertification. "
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Material issues related to the Bottled Water industry include sustainable water usage and extraction, water access rights and fair payment, and packaging life-cycle and waste management. Please see B Lab's Bottled Water statement for additional discussion on material issues and best practices.
IMPACT ON STAKEHOLDERS	80% of the company's revenue is comprised of bottled water sales.
IMPLEMENTED MGT PRACTICES	"Late's Strategic Plan outlines how the company is planning to meet the Bottled Water standards. Key points from the Strategic Plan include the below: - Recharge and extraction rates for their water sources that indicate sustainable water usage (i.e., extraction rates are below recharge rates) - Water management systems that monitor water losses - Funding for recurring hydrological studies for affected watersheds to monitor changes in recharge rates and ensure sustainable water usage - Community programs for the recycle and reuse of water containers"
