



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Company works with clients in the gambling industry
SUMMARY OF ISSUE	Exposure Ninja is a Digital Marketing Agency that has clients in the gambling industry. The company provides digital marketing and SEO services to their clients.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the FY21, 0.06% of the company's revenue came from gambling industry In the FY22, 0% of the company's revenue came from gambling industry.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
IMPLEMENTED MGT PRACTICES	Exposure Ninja has an ethical marketing policy in place for their own marketing policy which applies to their marketing and how they market for their clients. The company also claims to follow the guidelines/standards of the UK's Advertising Standards Authority (ASA). In relation to gambling sector clients specifically, Exposure Ninja mitigates these concerns by: i) Basing all messaging and content on facts and stats provided by the client; ii) Requesting clients evidence their sources for facts and stats to prevent false claims; iii) Including gambling awareness messages as relevant; iv) Requiring the client to brief our team on legislation within the sector relevant to marketing. Exposure Ninja's criteria to accept partnerships with companies within the gambling sector is as follows: i) They believe the business is lawful and abides by all relevant legislation; ii) The business can clearly show they operate in full compliance with the strict regulations of the UK Gambling Commission on behalf of the Department for Digital, Culture, Media and Sport (DCMS) under the Gambling Act 2005 in the UK; iii) They believe the business is not running scams or "tricking" customers; iv) They believe the business is not exploiting its workers or customers; v) They believe that the business does not do any dishonest marketing or financial schemes.
RELATED INCIDENTS (YES/NO)	Yes. In the last five years, the company has engaged with a client in the adult escorting industry. Exposure Ninjas has terminated their relationship with the client in this industry and is compromised in not working with this industry anymore.
