Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Litigation related to Labor
Summary of Issue	15 cases of Labor Disputes: 10 cases resulted in settlement agreements between the employee and the company. One of the main clauses of this agreement is reciprocal confidentiality on subjects and motives. In France, only the tax and social security authorities have the
	authority to waive this clause. 5 cases of Labor Disputes for wrongful termination in appeal process.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	10 cases of Labor contract disputes with settlement amounting to EUR 190,708 (<1% of revenue) 5 cases in appeal process of Labor Disputes for wrongful termination with settlement assessed <1% of revenue.
Impact on Stakeholders	Financial and well-being impact on former employees.
Resolution	All cases have been closed and all individuals were paid the corresponding compensation. 10 cases were settled with payment and 5 cases are in appeal process.
Implemented Management Practices	The company has an improved training and career management program. This includes 30 hours of training per year and implementation of a tool, Zest, for tracking skills. The company also set up internal missions within the firm to compensate employees for the inter-contract periods. There is also an improved follow-up of probation periods with a support process.
