

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	As a delivery company, Novex Delivery Solutions operates in an energy and emission intensive industry.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	"In the last fiscal year, 100% of the company's revenue was delivery services. Their fleet is powered by a combination of gas and electricity. Their emissions intensity as calculated by Offsetters is 0.0024 tCO2e/delivery."
IMPACT ON STAKEHOLDERS	The carbon emissions associated with their operations and their contribution to climate change along with air pollution and associated health impacts of air quality are the potential impacts of their energy intensity.
IMPLEMENTED MGT PRACTICES	"Novex's Clean Fleet Program is the company1s program that aims to have 100% of their fleet to be "clean"; vehicles those are rated as ultra-low emission or better. With their Clean Fleet they estimate they are able to save approximately 88 tonnes of carbon dioxide every year. Novex is expanding their clean fleet to include more hybrids, fuel efficient cars and trucks, and zero emission vehicles such as all electric trucks. Acknowledging that their goal of having 100% "clean" fleet is ambitious, they felt that they needed to address their environmental impact in more immediate terms with the use of carbon offsets. Since being carbon neutral, they have reduced their carbon footprint by 778 tC02e; a 43% decrease. The company has set the goal to be zero emission by 2030."
