



## DISCLOSURE MATERIALS

<b>SUMMARY OF ISSUE</b>	<p>The company was in a bankruptcy position back in 2017, losing 350K€ / year. It was losing money on every B2C sale. As a result the CEO had to cut as many jobs as possible in order to maintain the activity while having fewer losses.</p> <p>1. All key contact with the company were reduced to their bear minimum. As a result, several issues appeared such as:</p> <ul style="list-style-type: none"> <li>- inventory shortage</li> <li>- change and concentration of contacts during the tough times</li> <li>- decrease and reduction of regular communication to B2C customers</li> <li>- change in communication towards end users</li> <li>- change of marketing tone of voice from product oriented communication to sustainability oriented messages</li> </ul> <p>2. 2 people were laid off at that time.</p>

<b>IMPLEMENTED MGT PRACTICES</b>	<p>As part of the conventional termination, payment to Pôle Emploi to accompany the employees but none had any problems finding work afterwards.</p> <p>Employees were given better compensation than economic dismissal, and the company negotiated amicable departures,</p> <p>Chacun Son Cafe also put employees in touch with other professionals in the sector.</p>
