Topic	Clients in Controversial Industries
Summary of Issue	Seer Interactive is a digital marketing agency offering services including SEO, paid media, analytics, project management, creative and referral services. Over the last 5 years the company has had clients operating in the Alcohol, Cannabis-related products (excluding recreational marijuana), Fossil Fuels (Coal, oil sands), Gambling and Tobacco industries. The company's service can be sold to both companies operating in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The company has had one client operating in the alcohol industry representing 0.18% and 1 client in the Cannabis-related product Industry representing 1.05% of the company's FY2022 revenue. Clients in the Fossil Fuel (Coal, Oil sands) industry represented 0.36% of the company's FY2022 revenue (1 client). Clients in the Gambling industry represented 0% of revenue in FY2022 and an average of 0.27% of revenue over the last 5 years (1 client). Clients in the Tobacco industry represented 0% of revenue in FY2022 and an average of 0.51% of revenue over the last 5 years (1 client). The company does not currently have clients in Gambling and Tobacco Industries.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in

	controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company evaluates potential clients to ensure their business activities and intentions are aligned with ethical standards and principles. The company does not engage with clients involved in activities that contravene ethical norms, such as deceptive, harmful, or illegal practices, and is not planning to work again with companies operating in the Tobacco industry. Additionally, the company employs clauses in their service contracts to enforce these practices.
