Disclosure Questionnaire Category: Conduct Business in Conflict Zones

Topic	Company operates in Conflict Zones
Summary of Issue	World Extreme Medicine Ltd. provides medical education training courses, conferences and membership programs for medics (doctors, nurses, first responders etc.) in extreme situations and environments. The company currently operates Medics4Ukraine, which delivers lifesaving trauma supplies to medical professionals treating patients that were injured from the Russian invasion of Ukraine.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The company's Medics4Ukraine program has delivered over £3,178,350 worth of supplies and trained over 800 healthcare professionals in Ukraine.
Impact on Stakeholders	Business activities located in conflict zones are considered high-risk as they are more likely to cause or contribute to the conflict and/or sociopolitical instability. Countries classified as conflict zones are more likely to have a weak rule-of-law or a corrupt judicial system, which could undermine the effectiveness of operational grievance mechanisms for these businesses and their suppliers. In addition, the safety of the company's workers and other potential human rights violations are at risk.
Implemented Management Practices	The company has policies and practices in place that ensures the company's operations are not tied to the conflicts in the region and do not exacerbate the conflict. To mitigate the risks related to operating in conflict zones, the company conducts a risk assessment which determines what steps need to be taken. Some examples of these steps include (but are not limited to) required vaccinations and health screenings, pre-deployment security training, reporting mechanisms for corruption, use of secure travel vehicles and more.
