

Case Study

Standing On Giants x Beam

How a B Corp software platform supported 342 people via homelessness charity Beam, and saved thousands hedging its US dollars

Background

Standing On Giants (SoG) is a software platform that allows companies like Tesco, AirBnB and Canva build and manage online communities.

The FX challenge

With an array of US customers, and operations in the UK, Standing on Giants wanted to add both certainty to their cost base, with flexibility around that approach.

The GoodFX solution

A 0% deposit, 0% margin flexible forward product, that allowed SoG to manage this currency risk, draw down with flexibility, and without any additional cash burdens.

The impact

Through its initial FX trade, SoG generated over £5000 for its nominated charity Beam. This was donated to 342 individuals, helping them get jobs and find homes, pushing SoG to the top of Beam's corporate donation leaderboard for the month. Further quarterly trades are expected to generate thousands in donations on an ongoing basis.
