



DISCLOSURE MATERIALS

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Consumer Product Safety Recalls
SUMMARY OF ISSUE	The paper soup cup's labeling incorrectly instructed consumers to use the microwave for cooking, posing fire hazards. The recall was conducted with the Consumer Product Safety Commission, as this was a packaging issue and not an issue with food safety.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	229,194 units. All of the affected units have been removed from the marketplace and none remain. A new 3rd party certified microwaveable cup is now in the marketplace as the replacement for the original cup.
IMPACT ON STAKEHOLDER(S)	Burning cups presented a fire hazard to consumers. One minor injury was reported. Lotus Foods took quick action to remove affected cups from the marketplace so that minimal consumers were affected. Lotus Foods also worked quickly to determine a microwave safe cup to replace the soup cup product.
IMPLEMENTED MGT PRACTICES	Lotus Foods has implemented more stringent testing of food packaging to ensure safety when the product is being used. Packaging testing on microwaveable packaging by a 3rd party lab has been implemented. New Standard Operating Procedures around new product development and innovation have been implemented, this includes packaging testing.

OTHER MANAGEMENT COMMENTS	As a certified B Corporation, we put the health and safety of people first. We took swift corrective action when we discovered the issue and have added additional preventative safeguards to our processes. The CPSC recall has been closed as per the Feb 25, 2020 letter, see above link to view.
