Summary of Issue	Oktra Ltd is a company that does office design and fit-out in a variety of industries, including to some clients in controversial industries, such as Tobacco, Gambling, Fossil Fuels, For-profit Higher Education, Pharmaceuticals, Whole Life Insurance Products, Alcohol and Tax Advisory Services. The company provide services to both controversial and non-controversial industries
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the last 5 years, the average revenue generated from Clients in Controversial Industries are as follows: - Client(s) operating in the Tobacco industry represented 0.34%. - Client(s) operating in Gambling industry represented 0.49%. - Client(s) operating in the Fossil Fuels industry represented 1.09%. - Client(s) operating in the For-Profit Higher Education industry represented 0.82%. - Client(s) operating in the Pharmaceuticals industry represented 0.9%. - Client(s) operating in the Whole Life Insurance industry represented 0.8% in 2022. No revenue in the years preceding that. - Client(s) operating in the Alcohol industry represented 0.71% in 2022. No revenue in the years preceding that. - Client(s) operating in Tax Advisory Services represented 2.54%. The company has formally committed to the maximum scope thresholds for serving clients in the following industries: (Tobacco -> 0% of the company's annual revenue, Gambling -> 1% of the company's annual revenue)
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.

	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not currently have a position on working with clients in controversial industries.
Management Comments	Although the company has worked with clients in these industries, they are not actively targeting them.
